21 *ESTATE. The Lummi Probate Code allows a beneficiary of an estate to be appointed as*  
22 *Personal Representative, but cautions that person to always be mindful of the fact that the*  
23 *Personal Representative serves the estate in a fiduciary capacity and must put the interest of the*  
24 *estate ahead of the Personal Representative's personal interest.*
